## LCFA County Show Validation

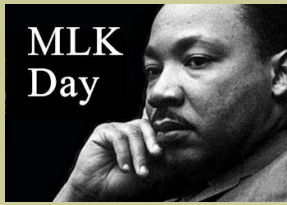


The **LCFA County Show Validation** date is on Saturday, January 9, from 8:00 a.m. – 11:00 a.m. at the County Show Barn. This will be for Market and Breeding Lambs, Market and Breeding Goats, Market and Breeding Swine, and Breeding Heifers.

## 4-H Meetings

Remember, members must be in good standing by attending at least **3 meetings or sanctioned events in their enrolled chapter**, prior to the 2016 Fair. Verification will be by official sign-in sheet. The 4-H members name must be on the sign-in sheet to be counted. The parents name will not count as verification that the child attended the meeting. You cannot get credit for meetings by attending another club's meeting, it must be in the club that you joined.
